**ADMISSION EXAMINATION FOR ENTRY INTO
ANGLO-CHINESE SCHOOL (INDEPENDENT)
YEAR 2 AND YEAR 3 – GCE O-LEVEL PROGRAMME (EXPRESS STREAM)
FOR ACADEMIC YEAR 2022**

Admission Examination for Enrolment

1. Anglo-Chinese School (Independent) conducts an annual admission examination for students who wish to enroll in the school in the GCE O-Level Programme (Express stream) for Academic Year 2022. This admission exercise is for students who wish to be admitted into Year 2 and Year 3. Applicants must fulfill the age requirement for the level of admission. This admission exercise is open to Singapore Citizens and Singapore Permanent Residents (Singapore PRs) who are in the Express stream in their current Ministry of Education (MOE) mainstream schools. International/foreign students (non-Singapore Citizens or non-Singapore PRs) who are currently studying in any MOE mainstream schools; and have been admitted to their current schools via MOE S1 Posting and not AEIS are also eligible to participate in the admission examination.

Students admitted via Direct School Admission-Sec (DSA-Sec)

2. Students who have been admitted to their current schools via DSA-Sec exercise should note that the DSA is a commitment made by the School to the students; and by the students and the parents to the receiving School. As such, they are not eligible to take part in the Yearly Admission Examination.

Integrated Programme (IP) Students admitted via PSLE Results

3. IP students who were posted to their current IP school via PSLE results will only be eligible to take part in the Yearly Admission Examination if there are extenuating circumstances for their application as they are strongly encouraged to complete and benefit from the customised 6-year Integrated Programme of their school. Please seek the advice and clearance from their current school before making an application.

International/Foreign Students

4. International/foreign students who are currently not studying in MOE mainstream schools are not allowed to take our Admission Examination. They are encouraged to take the MOE Admission Exercise for international Students (AEIS). Details of AEIS are available from MOE website - <https://www.moe.gov.sg/international-students/aeis> .

5. International/foreign students who have been admitted to their current secondary schools via AEIS are not allowed to take the Admission Examination.

6. Please note that there are no financial assistance schemes for international/foreign students.

Registration and Requirements

7. **In view of the COVID-19 situation, the school will only collect the non-refundable examination fee of S\$200.00 per applicant at a later time. We will advise applicants when payment can be made.** Payment can be by cheque made payable to ACS (Independent) or by PAYNOW (*note: please attach the payment slip if pay by PAYNOW*). Singapore Citizens in need of

financial assistance may apply to the school for subsidy of the examination fee by completing and submitting the “*Application for Subsidy of Yearly Admission Examination Fee for SCs only*” form. There are no financial assistance schemes for Singapore PRs and International/Foreign students. The application form should be submitted with the following documents to the school by postal mail as in view of the COVID-19 situation, you will not be allowed to enter our school premises. - Acknowledgement slip (page 4 of this document)
- One passport size photo to be pasted onto the application form
- Photocopy of applicant’s birth certificate or Singapore passport
- If Singapore PR - photocopy of applicant’s Singapore PR document
- If Foreigner - photocopy of applicant’s Singapore student pass or Singapore dependent pass or passport
- Photocopy of PSLE result slip that shows aggregate score (if applicable)
- For Year 2 admission - photocopies of Sec 1 examination reports/progress reports from current school
- For Year 3 admission – photocopies of Sec 1 and Sec 2 examination reports/progress reports from current school
- Photocopies of CCA records
- Photocopies of other relevant certificates

8. To pay by PAYNOW, please follow the below steps:

- Step 1. Log in to your bank’s mobile banking app
- Step 2. Scan the QR code using your bank’s app or key in our UEN code **T07GS7001AMSH**
- Step 3. Enter the amount to pay (S\$200)
- Step 4. Indicate ADEXAM and applicant’s name



9. Registration for the admission examination is confirmed only upon payment of the examination fee and complete submission of documents cited in the above paragraph 7.

10. The **closing date for all applications is no later than 3 pm, Friday, 24 Sep 2021**. Late applications will not be considered.

11. **The Admission Examination will be held on Saturday, 16 Oct 2021 from 8 am to 1 pm in our school premises.** Applicants are requested to report by 7:30 am at the examination venue(s). The examination schedule (subject to change at school’s discretion) is set out below:

12. Applicants who do not offer the Mother Tongue Language must provide a letter of explanation and documentary proof that they have not been offering these languages for the past 2 years in their current school. Upon offer of admission to our school, they may apply to MOE for exemption of Mother

Tongue Language or to offer a Foreign Language, e.g., French, German, Japanese, etc. in lieu of Mother Tongue Language. The outcome of application is subject to MOE's approval.

13. It is compulsory for applicants to sit for all the papers. Applicants who are exempted from Mother Tongue Language will be asked to leave the examination venue(s) after the first 3 tests. **Please note that there are no alternative examination dates.**

14. As the availability of places is limited, admission is based strictly on applicants' performances in the examination and on merit. Prospective applicants may be required to attend an interview with their parents or guardian.

15. **In view of the COVID-19 situation, the conduct of the Admission Examination will be aligned to the national safe management measures leading up to and during the actual test date. This means that all applicants are required to complete their Quarantine Order or Stay-Home-Notice prior to the test date to ensure the safety of all applicants and our examiners, and safe management measures will be in place during the conduct of the tests. Anglo-Chinese School (Independent) will keep applicants updated should there be any changes or cancellation of the Admission Examination.**

Results of Admission Examination

16. Offers to admission will only be made to successful applicants who meet the school's criteria for admission. Successful applicants will not be able to apply for Leave of Absence from school in their first year.

17. All applicants will be informed on the outcome of their applications by end November 2021 or early December 2021. Please note that detailed results of the Admission Examination will not be released; and the school is unable to provide information on application outcome or status over the telephone.
